NOTIFICATION

BUILDING AND OTHER CONSTRUCTION WORKERS (REGULATION OF EMPLOYMENT AND CONDITIONS OF SERVICE) ACT, 1996.

No. Emarat 2013/CR 104/Lab-7(A).—In exercise of the powers conferred by section 62 read with subsection (1) of section 22 of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (27 of 1996), the Government of Maharashtra, after consultation with the Expert Committee constituted under section 5 of the said Act, hereby makes the following rules to amend the Maharashtra Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2007, namely:—

- 1. These rules may be called the Maharashtra Building and Other Construction Workers (Regulation of Employment and Conditions of Service) (Amendment) Rules, 2013.
- 2. For rule 45 of the Maharashtra Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2007, the following rule shall be substituted, namely:—
 - "45. <u>Functions of the Board.</u>—(1) The Board may, by resolution, subject to the availability of Funds, provide the financial assistance to the beneficiary for the following purposes to such extent, as it deems fit, namely:—
 - (i) The following financial assistance for the education of children of the beneficiaries, namely:-
 - (a) for education of two female children studying in I to X Std. in the Government recognized schools, for every educational year;
 - (b) for two children securing minimum 50 % or more marks in X and XII standard examination;
 - (c) for two children studying in I, II and III year of graduation, towards <u>admission fees</u>, <u>purchase of books and educational material</u>, for every educational year;
 - (d) for two children studying for medical and engineering courses in the Government recognized Medical and Engineering Colleges and Institutes respectively, for every educational year;
 - (e) for two children studying from XII standard upto graduation as an encouragement, for every educational year.

- (ii) Subject to the terms and conditions as may be determined by the State Government, the medical expenses such as expenses for medical treatment, medication, hospitalization, surgery charges, doctor's fees, follow-up treatment, etc., incurred by the beneficiary, his spouse, his children below the age of 18 years and dependent parents, for the treatment of major ailments like heart disease, paralysis, tuberculosis, cancer, etc. and for such other ailments declared as major ailments by the State Government, from time to time.
- (2) The Board may, by resolution, subject to the availability of Funds, also make the provisions for the following other welfare measures and facilities under clause (h) of sub-section (1) of section 22 of the said Act, to such extent, as it may deem fit, namely:—
 - (a) premium under JanashreeBimaYojana of LIC of India payable for every beneficiary;
 - (b) a financial assistance for natural delivery and delivery by caesarcan operation to the wife of the beneficiary;
 - (c) a Family Welfare financial assistance to the only female child, where the beneficiary's husband or wife has undergone family planning operation after giving birth to only female child;
 - (d) a financial assistance to the beneficiary who has suffered 75% or more permanent disability due to accident while in service;
 - (e) an immediate funeral financial assistance to the nominee of the deceased beneficiary;
 - (f) per month financial assistance for a period of five years to the widow or widower of the beneficiary who died during the course of employment;
 - (g) one time financial assistance to the legal heir of the deceased beneficiary who died during the course of employment;
 - (h) supply of articles of daily needs, to the beneficiary;
 - (i) travel allowance to the beneficiary and his family members, viz. spouse and two children below the age of eighteen years, to the extent of 1,000 kilometers by the Maharashtra State Road Transport Corporation (M.S.R.T.C.) bus, once in a year;
 - (j) grant for meeting expenses of the first registered marriage of beneficiary;
 - (k) skill up-gradation training for beneficiary with stipend;
 - (l) establishment of training academy in the State, for the beneficiaries as per the directions of the State Government issued in this behalf, from time to time; and
 - (m) per year contribution of Rs.1,000/- to New Pension Scheme (NPS) account opened by the beneficiary under the Swavlamban Pension Scheme of the Government of India. ".
